The 34km of the dilapidated road D192 between GaRantlakane and Jakalaskei in Mogalakwena Local Municipality will undergo major rehabilitation on the 8km portion that is currently in a bad condition. MEC Namane Dickson Masemola said the Phase II of the road will focus on portion of the road which are not tarred, therefore the remaining kilometers will receive or undergo upgrading designs at the moment until there are enough resources to finish off the remaining kilometers.

The stakeholder engagement was attended by MEC for Department of Public Works, Roads and Infrastructure Hon. Namane Masemola together with the Mayor of Mogalakwena Local Municipality Cllr. Malesela Frans Mokwele and various stakeholders such as Royal Authorities, Community Forums and community members at the Bakenburg Traditional offices.

MEC Masemola apologized on behalf of the Department of Public Works, Roads and Infrastructure to the community and all the stakeholders involved given the delay

in the road

construction that led to a bad relationship between the department and the community.

“The road is going to be fixed as promised,” MEC Masemola emphasized on working together as one team which will help in finishing the project on time with good quality. He further showed that in many communities, projects are delayed by scandals and unrests between the community forums, community members and the constructors.

After a number of meetings which were held in trying to resolve the road issue, finally all parties could smile as they are now in agreement and the development of the road is finally going to start.

Although the department currently does not have enough budget, Mayor of Mogalakwena Local Municipality Cllr. Malesela Frans Mokwele appreciated the department for counting Mogalakwena Local Municipality as many roads in the area need to be developed. R40 million is budgeted for the major rehabilitation which will take place during this financial year.

MEC Masemola said “As previously promised that we will come back and address the challenges of this road, as a department we set aside R40 million for a major rehabilitation for some parts of the road (from GaRantlakane to Jakalaskei)”.

**M**EC Namane Masemola together with



Lepelle Nkupi Mayor Cllr Ms. Meriam Molala held an engagement with the community of GaLedwaba regarding road D3617 with the aim of finding solutions for the department, local municipality, community members and development forums moreover work together.

This is after the community protested and blocked the road demanding that the road be constructed as they have been waiting for it for some years. A large group of community members expressed their frustrations on the delays of road.

After a tough and hard meeting with the community leaders, MEC Masemola told the community that their road is going for designs through Lepelle Nkupi Local Municipality budget as the department is now in short of financial resources. The road construction will begin when the funds are sufficient.

The MEC pleaded with the community to be patient and to unite as that will help in fast-tracking the process of bringing in the road to the community. Lepelle Nkumpi Mayor Cllr Ms. Meriam Molala Meriam explained the procedure and the role in which the municipality will take in making sure that the road is constructed.

The upgrading of 3km on Road D3878 from gravel to bituminous seal that is the road from Sekororo to Ballon in Mopani District is at 95% completion despite being affected by the cyclone and heavy erosion in January.

# COVID-19 ADVICE FOR THE PUBLIC: GETTING VACCINATED

**T**he world is in the midst of a COVID-19 pandemic. The World Health Organization (WHO) and partners work together on the response -- tracking the pandemic, advising on critical interventions, distributing vital medical supplies to those in need--- they are racing to develop and deploy safe and effective vaccines.

**Q: What is the main aim of the vaccine?**

Vaccines save millions of lives each year. Vaccines work by training and preparing the body's natural defences – the immune system – to recognize and fight off the viruses and bacteria they target. After vaccination, if the body is later exposed to those disease-causing germs, the body is immediately ready to destroy them, preventing illness. There are several safe and effective vaccines that prevent people from getting seriously ill or dying from COVID-19.

This is one part of managing COVID-19, in addition to the **main preventive measures of staying at least 1 metre away from others, covering a cough or sneeze in your elbow, frequently cleaning your hands, wearing a mask and avoiding poorly ventilated rooms or opening a window.**

**Q: Which vaccines are out there?**

As of 8 April 2021, WHO has evaluated that the following vaccines against COVID-19 have met the necessary criteria for safety and efficacy:

- AstraZeneca/Oxford vaccine
- Johnson and Johnson
- Moderna
- Pfizer/BionTech

Some national regulators have also assessed other COVID-19 vaccine products for use in their countries.

Take whatever vaccine made available to you first, even if you have already had COVID-19. It is important to be vaccinated as soon as possible once it's your turn and not wait. Approved COVID-19 vaccines provide a high degree of protection against getting seriously ill and dying from the disease, although no vaccine is 100% protective.

**Q: Who should get vaccinated?**

**The COVID-19 vaccines are safe for most people 18 years and older, including those with pre-existing conditions of any**

infections that are stable and controlled. If supplies are limited in your area, discuss your situation with your care provider if you:

- Have a compromised immune system
- Are pregnant (if you are already breastfeeding, you should continue after vaccination)
- Have a history of severe allergies, particularly to a vaccine (or any of the ingredients in the vaccine)
- Are severely frail

**Q: What about children?**

**Children should not be vaccinated for the moment.** There is not yet enough evidence on the use of vaccines against COVID-19 in children to make recommendations for children to be vaccinated against COVID-19. **Children and adolescents tend to have milder disease compared to adults.** However, children should continue to have the recommended childhood vaccines.

**Q: What should I do and expect after getting vaccinated?**

Stay at the place where you get vaccinated for at least 15 minutes afterwards, just in case you have an unusual reaction, so health workers can help you.

Check when you should come in for a second dose – if needed. Most of the vaccines available are two-dose vaccines. Check with your care provider whether you need to get a second dose and when you should get it. Second doses help boost the immune response and strengthen immunity.

**Q: What about side effects?**

In most cases, minor side effects are normal. **Common side effects after vaccination, which indicate that a person's body is building protection to COVID-19 infection include:**

- Arm soreness
- Mild fever
- Tiredness
- Headaches
- Muscle or joint aches

Contact your care provider if there is redness or tenderness

(pain) where you got the shot that increases after 24 hours, or if side effects do not go away after a few days.

**Q: Any Do's and Don'ts?**

**If you experience an immediate severe allergic reaction to a first dose of the COVID-19 vaccine, you should not receive additional doses of the vaccine.** It's extremely rare for severe health reactions to be directly caused by vaccines.

**Taking painkillers such as paracetamol before receiving the COVID-19 vaccine to prevent side effects is not recommended.**

This is because it is not known how painkillers may affect how well the vaccine works. However, you may take paracetamol or other painkillers if you do develop side effects such as pain, fever, headache or muscle aches after vaccination.

**Even after you're vaccinated, keep taking precautions**

While a COVID-19 vaccine will prevent serious illness and death, we still don't know the extent to which it keeps you from being infected and passing the virus on to others. The more we allow the virus to spread, the more opportunity the virus has to change.

**Continue to take actions to slow and eventually stop the spread of the virus:**

- Keep at least 1 metre from others
- Wear a mask, especially in crowded, closed and poorly ventilated settings.
- Clean your hands frequently
- Cover any cough or sneeze in your bent elbow
- When indoors with others, ensure good ventilation, such as by opening a window

Doing it all protects us all.

# HOW TO MONITOR & REPORT COVID-19 VACCINE SIDE EFFECTS

Health workers play a key role in ensuring the continued safety of COVID-19 vaccines

## BEFORE VACCINATING



### STEP ONE **ASK**

If the person getting vaccinated has ever had a severe allergic reaction to a vaccine



If YES, refer the person to an allergy specialist or health provider, who will recommend next steps



### STEP THREE **COMMUNICATE**

common side effects after vaccination, which indicate that a person's body is building protection to COVID-19

Common side effects include:

- Arm soreness
- Mild fever
- Tiredness
- Headaches
- Muscle or joint aches



### STEP TWO **ASSESS**

any health or medical conditions listed as precautions by the vaccine manufacturer or by your local immunization programme

These conditions may include:

- Pregnancy
- Compromised immune system
- Severe frailty among older persons

*People with these conditions are eligible for vaccination, but should be offered information & counselling*

### STEP FOUR **VACCINATE**



## AFTER VACCINATING



### STEP FIVE **OBSERVE**

the vaccinated person for 15 minutes – tell them how & where to report severe reactions

- Observe people with a past vaccine allergy for 30 minutes, after they have been approved by a specialist (step 1)

### STEP SIX **INFORM**

your supervisor immediately of any unexpected or severe reactions during the observation period or reported later

- Complete an electronic or paper Adverse Events Following Immunization (AEFI) form, available online at [investigation.gvsi-aeftools.org](https://investigation.gvsi-aeftools.org)
- Health officials will then investigate the event

# HEALTH AND WELLNESS CALL FOR LIFESTYLE CHANGE

# EHW THERE FOR ALL EMOTIONAL DISTRESS

**C** COVID-19 pandemic mandated every country in the world to put measures that affected the psychological level of the citizens. The restrictions and regulations were placed to save lives amidst daily threats of 3rd COVID-19 wave, infections and death statistics being reported in all platforms i.e. radio, television and social media.

The bereavement, isolation, quarantine, loss of income even fear and anxiety are a daily struggle for many and existence are awful. Moreover because close friends, colleagues even relatives are still unable to support the affected in fear of the infections. This on its own makes grieving, healing and sufferings in distant the order of the day, to many the new normal.

Then the question arise, in such status of new normal, where can one get emotional stability. Have a safe environment to get a session without incurring costs. Is then I found that the department has **Clydagh Margarette Lundie** and **Motshutshu Bruce Maapolele**, who are employed under Employee Health and Wellness Head Office as student Psychologists.

Their deployment could not have come at a better time where their expertise or experience are crucial to assist staff members in dealing with emotional distress that the pandemic brought.

In Maapolele's own words the COVID-19 pandemic "created a panic." He said during the pandemic, he developed a coping mechanism—"talking, sharing with

colleagues and interacting with people." He shared how some of his friends, family members jobs and lives were impacted by the pandemic "the economy created double impact" he said.

Although bereavement has always been part of human existence, they both found themselves regularly involved with deep briefing and bereavement counselling since the national lockdown in March 2020. "It is a flip side of a coin, one moment you are scared then also have to provide counselling" said Lundie. She further elaborated that "it is rewarding because you can see how you tangibly assisting during the pandemic."

According to Lundie, being a student psychologist has added to her personality growth and also her way of thinking. This she said developed by learning her boundaries and having a support system that taught her accountability and personal empowerment. She plans to continue studies in clinical psychology despite learning institution criteria, "universities are taking 6-8 students per year and criteria is very selective."

Staff members can use the services of the Employee Health and Wellness services near their areas of work and engage these two student Psychologist on all emotional distress counselling session they require, of course in the presence of their mentors within the directorate.

This is way the Department is giving back through youth development and employment opportunities.



