Department of Public Works merging partnership with CETA

On the 17th of October 2012, the Department of Public Works and CETA (Construction Education and Training Authority) launched a new project at Landmark Hotel. CETA has given the department 18 million grants for enrichment of the youth. In her budget speech for 2012/13 MEC Thabitha Mohlala indicated that the department plans to :Establish an Artisans Development Programme (Apprenticeship) for 346 learners for a period of two years and to enroll all 186 Community House Building NQF level 2 Learners with FETs, to further their training in order to enhance their acquired skills. The department engaged CETA and submitted business plans hence this particular partnership .

The department and CETA want to improve the living standards of the youth by providing them with technical skills that are scarce within the country that they will be able to utilize in the future. The 500 youth learners will be enhanced with skills and they will become full artisans, who are much needed in the department. "Educating and skilling of these 500 youths will enable the department to meet our objectives as set in our 2010 -2014 strategic documents, " the MEC indicated.

- Act as referral agent of employees to relevant internal or external health support programmes.
- Be involved with the identification of employees at risks for TB transmission at the workplace.
- Support employees on TB AND/ OR ARV treatment to adhere to treatment (act as DOTS supporter/ ARV Buddy),
- Submit monthly reports of activities to the HIV & AIDS and TB coordinator.
