The programme has been developed in such a way that it enables close working partnership between all stakeholders. EPWP head office official will work with the ECD coordinators at district level under Education and Social development and of course also work with ECD's themselves and their committees.



3. Introduction

Limpopo Province has the 4th largest population in South Africa at 5.6 million (12%). Women make up to 55% of the adult population while the youth constitute about 35% of the population. The bulk of the economically active population is unskilled or semi-skilled and the overall level of poverty in the Province is relatively high currently estimated at 60%. The unemployment rate is estimated to be 49% and is the second highest in the country. Women, youth and people with disabilities are the most affected and make up the larger portion of the poor in the Province. In addition, due to mainly historical imbalances, basic infrastructural services are in a deplorable state coupled with massive backlogs in construction and maintenance of public infrastructure. These pose significant socio-economic challenges to the province.

The National and Provincial governments initiated several development projects in the Province aimed at mitigating the above challenges since the establishment of the democratic dispensation in 1994 and launch of the Expanded Public Works Programme in 2004. One of the most significant ones is the Expanded Public Works Programme (EPWP). The EPWP is a Government's strategic initiative aimed at addressing unemployment and improving the livelihoods of the poor; mainly women, youth and people with disability. The programme covers all spheres of government and state-owned enterprises.

In line with the above overall National Government policy and with due consideration of the socio-economic situations of the Province, the Limpopo Cabinet in January 2005, outlined and approved the Provincial EPWP strategy. It also mandated the Limpopo Department of Public Works (LDPW) to coordinate the implementation of the programme in the Province.

The LDPW through its EPWP Directorate is coordinating programme activities in four sectors namely, Economic, Environment, Infrastructure and Social. It is also offering assistance and guidance to the implementing agencies (the government departments, municipalities and other public bodies), in terms of the identification, planning and implementation of projects according to the EPWP principles, guidelines and procedures.

Given the fact that November month is declared the month of the children, the LDPW has through the EPWP directorate decided to support the month by supporting needy ECD"S in the rural area of Blouberg Municipality by supplying them with educational toys and aprons for the children.

The Blouberg Municipality was chosen because it is a rural and a poor municipal area.



4. Project Description

The project is located in the Capricorn district of the Limpopo Province.

The chief objective of the project is to provide 50 ECD sites with toys and aprons thereby creating a conducive learning environment for the children and to begin to ratchet the ECD programme in the Province.

5. Current Situation

The Social Sector is implementing the Early Childhood Development Programme is part of the premier programme of the EPWP Social Sector project.

6. Policy Implications

The Deputy President has issued a directive to the EPWP to ratchet the ECD programme as part of goal realisation for children development.

7. Beneficiary Details

- Beneficiaries are estimated at 2,500 pupils from different ECD sites in the Blouberg Municipality.
- There are 50 ECD sites expected to benefit from this initiative.

8. Implementation Plan for EPWP Projects

Implementation of the project will be carried out as a normal EPWP project whereby the LDPW procures goods for the ECD sites as per the supply chain management framework.

9.1 Project Design

The LDPW will purchase all the aforementioned goods on behalf of the ECD sites.

- Social facilitation with ECD sites committees.
- The ECD sites will ensure that all goods purchased are recorded in their asset registers and they remain the property of the site.
- An official handover of the goods will be conducted by LDPW.

9.5 Programme Management

The EPWP Social Sector Coordinating Directorate will be responsible for the purchase of the toys and the aprons. They will also do the overall management and coordination of the project including the official hand over of the purchased goods.



The ECD sites will see to the safe keeping and looking after the goods which are part of EPWP support to implementing agents of the programme.

9.6 Roles and responsibilities

10. Sustainability of the Programme

This Early Childhood Development Programme is a sustainable programme supported by National Treasury and the Presidency. As long as South Africa has children

11. Monitoring & Evaluation

- The Department of Education and the Social Sector Coordinators will do monitoring and Evaluation of the project..
- The ECD district coordinators will also assist in ensuring the safe keeping of the goods when they do inspection and site visits.

12. Project Budget

The total budget for the purchase of educational toys and aprons for the ECD children will be R 190,000.00 for aprons and R200, 000.00 for educational toys, to be defrayed from Vote 9 Programme 3 EPWP I which represents the direct inputs in reorientation of budgets to meet objectives of EPWP.

13. Time Plan

PURCHASE OF THE GOODS	The EPWP directorate will submit the business plan and liaise with the Supply Chain Management for the procurement of the goods. This process must be started and finalized before the 16 th November 2007.

The specification of all the goods to be purchased must comply with the specifications as prescribed by the Department of Education for Educational Toys and learning materials. It will further have to comply with the Supply Chain Management Framework.
