- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;

2. PURPOSE

The Limpopo Department of Public Works, Roads and Infrastructure is looking for suitably qualified and experienced Travel Management Companies with an impeccable track record to provide Travel Management Service for a period of thirty-six (36) months.

3. BACKGROUND

The Department is event driven, as such its officials will be required to travel for business purposes nationally and internationally. Travel arrangements will consist of hotel accommodation, air & road transport, shuttle services, car rentals, conferencing packages and registration fees. The Department also has a responsibility to transport stakeholders to the Departmental events and commitments.

4. SCOPE OF WORK

The **Travel Management Company** will be expected to render travel management services that are consistent and reliable. The service will consist of hotel accommodation, air and road transport, shuttle services, car rentals and registration fees. The Department will appoint a Travel Management Company to manage all the Districts (with their Cost Centres) and Head Office within the Limpopo Province.

5. SERVICE REQUIREMENTS

- 5.1.** The service provider will be required to provide travel management services. Deliverables under this section includes without limitation, the following:

- 5.1.1.** The travel management services will be provided to all travellers on behalf of Limpopo Department of Public Works, Roads and Infrastructure, locally and internationally. This will include all officials, executive authority, service consultants and clients where the agreement is that the Limpopo Department of Public Works, Roads and Infrastructure is responsible for the arrangements and cost of travel.
- 5.1.2.** Provide Travel management services during the normal working hours (Monday to Friday 07h30-17h00) and provide after hours and emergency services from 17h00 to 07h30
- 5.1.3.** Penalties incurred as a result of the inefficiency or fault of a travel consultant will be for the TMC account, subject to the formal outcome of a formal dispute process.
- 5.1.4.** Manage the third-party service providers by addressing service failures and complaints against these service providers.
- 5.1.5.** The **Travel Management Company** will be required to comply with National Treasury and Provincial Treasury and any other legislations related to Travel Management Services.

6. RESERVATIONS

- 6.1.** The Travel Management Company will:

- 6.1.1.** Receive travel requests from travellers and/or travel bookers, respond with quotation (confirmations) and availability. Upon receipt of the relevant approval, the travel agent will issue the required e-tickets and vouchers immediately and send it to the travel bookers and traveller via the agreed communication medium.
- 6.1.2.** Always endeavour to make the most cost-effective travel arrangements based on the request from the traveller and/or travel booker.

- 6.1.3. Appraise themselves of all travel requirements for destinations to which travellers will be travelling and advise the traveller of alternative plans that are most cost effective and more convenient where necessary.
- 6.1.4. Obtain a minimum of three or more price comparisons for all travel requests where the routing or destination permits.
- 6.1.5. Book the negotiated discounted fares and rates. Must keep abreast of carrier schedule changes as well as all other alterations and new conditions affecting travel and make appropriate adjustments for any changes in flight schedules prior to or during the traveller's official trip. When necessary, e-tickets and billing shall be modified and reissued to reflect these changes.
- 6.1.5.
- 6.1.6. Book convenient parking facilities at the airports where required for the duration of the travel.
- 6.1.7. Responds timely and process all queries, requests, changes, and cancellations timeously and accurately.
- 6.1.8. Issue all necessary travel documents, itineraries, and vouchers timeously to traveller(s) prior to departure dates. (Including Short Message Service confirmation).
- 6.1.9. Advises the Traveller of all visa and inoculation requirements well in advance.
- 6.1.10. Assist with the arrangement of foreign currency and the issuing of travel insurance for international trips where required.
- 6.1.11. Visa applications will not be the responsibility of the TMC; however, the relevant information must be supplied to the traveller(s) where visas will be required.
- 6.1.12. Where pre-payments are required for bookings, it will be the responsibility of the TMC.
- 6.1.13. Facilitate any reservations that are not bookable on the Global Distribution System (GDS).
- 6.1.14. Facilitates the bookings that are generated through their own or third-party Online Booking Tool (OBT) where it can be implemented.

- 6.1.15. All cases include domestic, regional, and international travel bookings.
- 6.1.16. Ensure confidentiality in respect of all travel arrangements concerning all persons requested by the Limpopo Department of Public Works, Roads and Infrastructure.
- 6.1.17. Submission of proof that services have been satisfactorily delivered (invoices) as per Limpopo Department of Public Works, Roads and Infrastructure instructions.

7. ACCOMMODATION AND FULL CONFERENCE PACKAGE

- 7.1. The TMC will obtain a minimum of three or more price comparisons from accommodation establishments that provide the best available rate within the maximum allowable rate and that is located as close as possible to the venue or office or location or destination of the Traveller.
- 7.1 This includes planning, booking, confirming, and amending of accommodation with any establishment (hotel group, private hotel, guest house or Bed & Breakfast) as per applicable National /Limpopo Provincial Treasury Instruction Note at the time.
- 7.2 The Limpopo Department of Public Works, Roads and Infrastructure shall negotiate for better corporate deals with service providers and the Limpopo Department of Health travellers may only stay at accommodation establishments with negotiated corporate rates. Should there be no rate agreement in place in the destination, or should the contracted establishment be unable to accommodate the traveller, the Service Provider will source suitable accommodation bearing in mind the requirement of convenience for the traveller and conformation with acceptable costs, or as stipulated in written directives issued from time to time by the National/Limpopo Provincial Treasury or Limpopo Department of Public Works, Roads and Infrastructure.
- 7.3 Accommodation and conference package vouchers must be issued to all Limpopo Department of Public Works, Roads and Infrastructure travellers for accommodation and conference package bookings and must be invoiced to Limpopo Department of Public Works, Roads and Infrastructure as per arrangement. Such invoices must be supported by a copy of the original hotel accommodation / conference package charges.

- 7.4 The Service Provider must during their report period provide proof, where applicable, that accommodation and conference package rates were booked within the allowable rates as per the cost containment Instruction Note of the National / Limpopo Provincial Treasury.
- 7.5 Cancellation of accommodation/conference package bookings must be done promptly to guard against no show and late cancellation fees.
- 7.6 The Service Provider will obtain three price comparisons from facilities/ establishments that have a hall/atrium that will provide the best available rate within the maximum allowable rate and that is located as close as possible to the venue or office. This includes booking, confirming, and amending of a hall rental with any establishment (churches, school, tents) as per applicable National /Limpopo Provincial Treasury Instruction Note at the time.

8 CAR RENTAL AND SHUTTLE SERVICES

- 8.1 The TMC will book the vehicles as per the approved category of vehicles from the closest rental location (airport, hotel, and venue). Confirmation of bookings must include SMS confirmation.
- 8.2 Limpopo Department of Public Works, Roads and Infrastructure travellers may only stay at accommodation establishments with which Limpopo Department of Public Works, Roads and Infrastructure has negotiated corporate rates. Should there be no rate agreement in place in the destination, or should the contracted establishment be unable to accommodate the traveller, the TMC will source suitable accommodation bearing in mind the requirement of convenience for the traveller and conformation with acceptable costs, or as stipulated in written directives issued from time to time by the National treasury or Limpopo Provincial Treasury.
- 8.3 Accommodation vouchers must be issued to all Limpopo Department of Public Works, Roads and Infrastructure travellers for accommodation bookings and must be invoiced to Limpopo Department of Public Works, Roads and Infrastructure as per arrangement. Such invoices must be supported by a copy of the original hotel accommodation charges.
- 8.4 The TMC must during their report period provide proof, where applicable, that accommodation rates were booked within the maximum allowable rates as per the cost containment instruction of the National Treasury.

- 8.5** Cancellation of accommodation bookings must be done promptly to guard against no show and late cancellation fees.
- 8.6** The travel consultant should advise the Traveller on the best time and location for collection and return considering the Traveller's specific requirements.
- 8.7** For international travel the TMC may offer alternative ground transportation to the traveller that may include rail, buses, and transfers.
- 8.8** Rental of buses/luxury coaches will be provided as Limpopo Department of Public Works, Roads and Infrastructure.

9 AIR TRAVEL

- 9.1** The service provider must be able to book full-service carriers as well as low-cost carriers.
- 9.2** The service provider will book the most cost-effective airfares possible for domestic travel.
- 9.3** The TMC will obtain three or more price comparisons where applicable to present the most cost effective and practical routing to the Traveller.
- 9.4** Airline tickets must be delivered electronically (via email) to the traveller(s) promptly after booking before the departure dates (including SMS confirmation).
- 9.5** For international flights, the airline which provides the most cost effective and practical routes, shall be used.
- 9.6** The airline ticket should include the applicable airline agreement number as well as the individual loyalty program number of the traveller (if applicable)
- 9.7** The service provider shall also be responsible for tracking of unused e-tickets as per agreement with the institutions and provide a report on refund management once a quarter.
- 9.8** The service provider shall during the reporting period provide proof of bookings made against the discounted rates on the published fares where applicable.
- 9.9** Ensure that travellers are always informed of any travel news regarding airlines (like baggage policies, checking in arrangements)
- 9.10** Assist with lounge access when required.

10 AFTER HOURS AND EMERGENCY SERVICES

- 10.1** The TMC must provide a consultant or team of consultants to assist Travellers with after hours and emergency reservations and changes to travel plans.
- 10.2** A dedicated consultant/s must be available to assist DEPARTMENT OF PUBLIC WORKS, ROADS AND INFRASTRUCTURE travellers with after hours or emergency assistance.
- 10.3** After hours' services must be provided from Monday to Friday outside the official hours (17:00 to 7:h30) and twenty-four (24) hours on weekends and Public Holidays.
- 10.4** A call centre facility or after hours contact number should be available to all travellers so that when required, unexpected changes to travel plans can be made and emergency bookings attended to (in all travel confirmations)
- 10.5** The TMC must have a standard operating procedure for managing after hours and emergency services.

11 COMMUNICATION

- 11.1** The travel management company may be requested to conduct workshops and training sessions for travel bookers of Limpopo department of Social Development
- 11.2** All enquiries must be investigated, and prompt feedback be provided in accordance with the service level agreement.
- 11.3** The service provider must ensure sound communication with all stakeholders. Link the travellers, travel coordinator and the department in one smooth workflow

12 COST MANAGEMENT

- 12.1** It is the obligation of the travel management company to always advise on the cost-effective option, and costs should be within the framework of the National Treasury's cost Containment instructions.

- 12.2** The service provider plays a pivotal role to provide high quality travel related services that are designed to strike balance between effective cost management, flexibility, and travel satisfaction.

13 BID AWARD AND CONTRACT CONDITIONS

- 13.1** Each bid, once submitted, constitutes a binding and irrevocable offer to provide the required goods on terms set out in the bid, which offer cannot be amended after its date of submission except for arithmetic errors.
- 13.2** Bidders must submit their bid in line with the bid specification. Failure to comply shall invalidate the bid.
- 13.3** The department reserves the right to verify any information supplied by the bidder and should the information be found to be false or incorrect, the department will exercise any of the remedies available to it.
- 13.4** Awarding of the bid shall be subject to the Travel Management Company(s) acceptance of National Treasury General Conditions of Contract (GCC).
- 13.5** The successful bidder will be bound by the Government Procurement: General condition of contract will form part of the signed contract with the successful bidder.
- 13.6** The department will verify supplier compliance on the Central Supplier Database report.
- 13.7** Limpopo Department of Public Works, Roads and Infrastructure reserves the right to award the bid to one or more Travel Management Company.
- 13.8** The department may, on reasonable and justifiable grounds, award the bid to a company that did not score the highest number of points.
- 13.9** The award of the bid may be subjected to price negotiation with the preferred bidders
- 13.10** The department further reserves the right to reject all or individual items of this bid and/or award all or individual items of this bid.
- 13.11** Bidders shall be notified about the departmental decision by means of publication in the Provincial Bid Bulletin, E-Tender Portal, and Departmental website.
- 13.12** The contract period will be from the commencement date of the contract.
- 13.13** The contract shall be concluded between Limpopo Department of Social Development and the successful Travel Management Company(s).
- 13.14** The Department expects appointed Travel Management Company(s) to take full responsibility and accountability to execute functions attached to the contract.

- 13.15** The department reserves the right to verify any information supplied by the bidder and should the information be found false or incorrect, the department will disqualify the bid and may further exercise any of the remedies available to it

14 CONTRACT ADMINISTRATION

- 14.1** Successful bidder(s) must report to the department within twelve (12) hours when unforeseeable circumstances will adversely affect the execution of the contract.
- 14.2** Full particulars of such circumstances as well as the period of delay must be furnished.
- 14.3** The administration of the bid and contract i.e., evaluation, award, distribution of contract circulars, contract price adjustments etc., shall be the sole responsibility of the Supply Chain Management Unit.
- 14.4** Department of Public Works, Roads and Infrastructure shall provide monitoring and evaluation of the services rendered.
- 14.5** The Travel Management Company shall compile and submit monthly reports to the Department of Public Works, Roads and Infrastructure.
- 14.6** Quarterly meetings shall be held with the Travel management company to assess the implementation of the programmes.
- 14.7** The Travel Management Company is required to submit monthly, quarterly, annual reports and any other report as may be required by the Department according to formats required of the Department.
- 14.8** The TMC shall submit to DEPARTMENT OF PUBLIC WORKS, ROADS AND INFRASTRUCTURE at least three copies of comparative price quotations for each transaction.
- 14.9** Should DEPARTMENT OF PUBLIC WORKS, ROADS AND INFRASTRUCTURE discover and establish that the booked transport, and /or accommodation were not the lowest available and that such deviation cannot be justified, DEPARTMENT OF PUBLIC WORKS, ROADS AND INFRASTRUCTURE reserves the right to impose a monetary penalty to the value of (10%) percent of the total value of each transaction tainted by an unjustified deviation from the expected standard.
- 14.10** Every invoice submitted to the Department should be accompanied by the hotel bill.

- 24.2 Preference points allocated for women may be claimed if there is sufficient evidence that such woman has ownership of 51% or more of the enterprise shareholding. (Bidders to submit certified copy of South African Identity Document.)
- 24.3 Preference points allocated for persons living with disabilities may only be claimed if there is sufficient evidence. (Bidders to submit a letter from Health Professionals)
- 24.4 Preference points allocated for promotion of SMMEs may be claimed if there is sufficient proof. (Bidders to submit Financial Statements)
- 24.5 Preference points allocated for enterprise located in Limpopo Province may be claimed only by companies operating within the borders of Limpopo Province. (Bidders to submit proof of residence of where the enterprise is located or lease agreement.)
